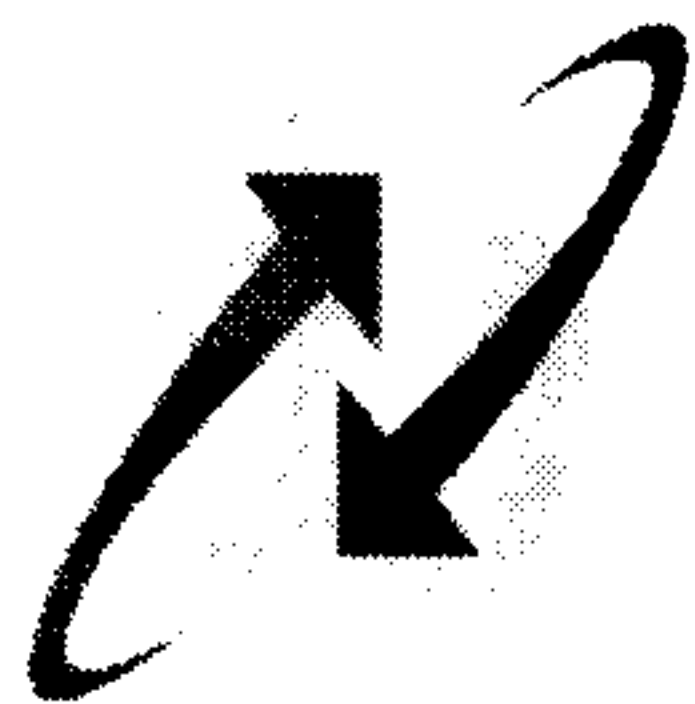

**Subject: Adoption of CPWD Works Manual 2014 & DSR-2014 in BSNL –Reg.**

Upon creation of P&T Civil Wing, guidelines were issued vide letter No. 13(13)63-A&C/89 dated 9<sup>th</sup> July 1963 for applicability of CPWD codes, Manuals, Procedures in the P&T Civil Wing. In view of revision of publications by CPWD, instructions were issued for adoption of CPWD Works Manual 2012 & DSR-2013 in BSNL vide even No. 59 dated 12/06/2012 & even No.63 dated 11/09/2013.

Recently, CPWD has issued **CPWD Works Manual 2014** incorporating the changes in Works Procedures through various circulars issued since CPWD Works Manual 2012 and Delhi Schedule of Rates-2014 i.e. **DSR-2014** based on prevailing market rates in Delhi as on 01/04/2014 & including new items for current requirements like items on Green Building Concepts etc.

Now, in view of above, the approval of competent authority is hereby conveyed for adoption of:

- I. **CPWD Works Manual 2014** for execution of works in BSNL except the Delegated Financial Powers, Rules for Enlistment of Contractors, 2/3 bid system, Tender Documents and any other specific instructions/guidelines issued by BSNL from time to time. Any ensuing amendments to the CPWD Works Manual 2014, issued by CPWD, will also be applicable to BSNL in accordance with the earlier instructions issued by this office vide even letter No 59 dated 12/06/2012.
- II. **DSR-2014** i.e. **Delhi Schedule of Rates-2014** with the condition that for BSNL Internal works the Contractor Profit & overheads shall be limited to 10% instead of 15% and for External/PMC Works Contractor Profit & overheads shall be kept as 15% as per CPWD Works Manual-2014 & DSR-2014 and as per the guidelines issued vide this office even letters No.180 dated 06/08/2008 and No 181 dated 07/08/2008.

This is issued with the approval of competent authority.
